

#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Plorids Statutes, adopts the following articles of incorporation for such corporation.

# ARTICLE I

The name of the corporation is:

# ARTICLE II

The period of caration of this corporation is perpetual, unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

# ARTICLE III

The purpose or purposes for which the corporation is organized are:

- A. To engage in and transact any lawful business for which not-for-profit corporations may be incorporated under the Florida General Corporation act. No other purpose limits this general purpose in any way.
- To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To engage in the business of promoting the enjoyment of, and use of, the state recreation area known as Delnor-Wiggins Paes State Recreation Area, located in Collier County, Florida.

1. ARTICLE III of the Articles of Incorporation shall be amended as follows:

#### ARTICLE III

The purpose or purposes for which the Gerperatien SUPPORTERS OF DEL-NOR WIGGINS PARK, INC. is organized are:

- A. Exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue law. Further, within the limitations specified in the sentence above, Te to engage in and transact any lawful business for which not-for-profit corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To engage in the business of promoting the enjoyment of and use of, the state recreation area known as Delnor-Wiggins Pass State Recreation Area, located in Collier County, Florida.
- 2. ARTICLE VIII of the Articles of Incorporation shall be amended as follows:

#### ARTICLE VIII

Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 510 (c)(3) of the Internal Revenue Code of 1954 or the corresponding sections of any prior or future United States Internal Revenue law, In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501 (c)(3) and 170 (c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal State or local government for exclusive public purpose.

BE IT RESOLVED by the Board of Directors of the SUPPORTERS OF DEL-NOR WIGGINS PARK, INC. that amendments be proposed to the Articles of Incorporation to conform to the requirements of the Internal Revenue Service as specified in a letter from them dated May 23, 1988 to qualify for tax exempt status.

BE IT FURTHER RESOLVED that the proposed amendments to the Articles of Incorporation, attached hereto, be submitted to a vote at a special meeting of members of the SUPPORTERS OF DEL-NOR WIGGINS PARK, INC., in conformity with Section 617.017, Florida Statutes, and that proxies be solicited for such special meeting in an effort to secure an "affirmative vote of a majority of the votes of members" of this corporation, as required by Section 617.017 Florida Statutes.

BE IT FURTHER RESOLVED that "notice of a Special Meeting" of the SUPPORTERS OF DEL-NOR WIGGINS PARK, INC. be given to the members to be held on \_\_\_\_\_\_\_\_, 1988, for the purposes of considering and approving the proposed amendments (attached hereto) to the Articles of Incorporation.
