#### **President's Report: Janice Kmetz**

- The "Park Update" prepared by Assistant Park Manager Nicoletti and posted on social media helped answer questions about progress on Park post-hurricane work and renovations.

## Vice-President's Report: Kim Finer

- Kim reported that she and Donna has a successful day at the Conservancy of S. W. Florida Earth Day event. Information about the Park and Friends group was shared. Park logo stickers and buttons were given away. Donations from the event were \$400.00. Board members recommended participating at this event in the future.

# Secretary's Report: Valerie Thompson

# **Treasurer's Report: Eric Cosentino**

Year-over-year for the period ending March 31st, total assets increased to \$224,729.23, up \$17,314.19 or 7.7%. Direct public support was up \$3,364.93 or 30.9%. Membership was down \$5,274.81 or 77.7%. Total income was down \$3,740.17 from a year ago. Expenses were down \$20,377.78 and net income was up \$16,637.81 from a year ago.

Eric reported on the boat donation that has been offered to the Friends. The donation should be completed in a week or two.

- Current membership is 177.

#### Turtle Nest Upate. Donna Graham

- Donna reported 46 nests have been adopted. It was suggested an October event be held for Turtle Nest Adopters to distribute certificates, meet and greet and say thank you.
- Nest adoptions will take place throughout the season this year.

<u>Compliance request:</u> Following submission of the Friends response letter concerning the compliance request from the Florida Department of Agriculture and Consumer Services, the situation has been resolved and approved. The Friends "non-profit" status stands. No penalties were imposed.

#### **New Business:**

- The Bonita Springs Shell Club, which made a donation to the Friends, will be meeting with Janice on the beach Thursday, June 9, area #2 for a Park tour.
- Mark, Kim and John Finer and the District biologists have met to discuss the "Mobile Plant Propagation" grant, requirements, regulations, etc. The \$10,000 grant is funded by the State Park Foundation.
- Friends Newsletter: next addition is July 1. Send Kim information you think should be included.
- Summer Camp at the Park starts June 3 and goes through the first week in August. The Camp will be set up on the boat ramp parking lot. Same organizer as previous years.
- Turtle Nesting Information Banner: Janice requested a banner to be placed at the entrance to the Park. She is working with Cecil's Printing to have a banner produced. Janice will work with Park staff to have the banner displayed.
- Donna proposed two additions/changes to the "Friends of Delnor-Wiggins Pass State Park Bylaws", Article VI and Article VII Board of Directors section:
  - Article VI, Section 1: Requirement and Responsibilities: To become a member of the Board of Directors a nominee must have been an active member of the Friends of Delnor-Wiggins Pass State Park for a period of one (1) year prior to being nominated.
  - Article VII, Section 1: Election of Officers: To be elected as an officer of the Board of Directors, a
    director must serve the first year of the 3-year term, with exception: when vacancy(ies) cannot
    be filled because no board member meets the aforementioned requirement. Following
    discussion, Valerie made a motion to accept the changes to the Bylaws as stated by Donna (see
    above); Kim seconded the motion. Unanimously approved. Donna will update the Bylaws.
